

Model Resolution for a State Legislature to Urge Congress to *Get US Out!* of the USMCA

A Concurrent Resolution from the Legislature of the State of _____
To the Congress of the United States of America and to the
Congressional Delegation of the State of _____

A Petition to Congress

A RESOLUTION urging Congress to reject the economic and political integration of the United States, Mexico, and Canada into an EU-style North American Union (NAU) by withdrawing the United States from the United States-Mexico-Canada Agreement (USMCA):

WHEREAS the Declaration of Independence proclaims: “We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable Rights ... that to secure these rights, Governments are instituted among Men....”; and

WHEREAS according to the Declaration of Independence the purpose of our constitutional Republic is to secure our precious rights, such as the right to life, the right to the free exercise of religion, the right to freedom of speech, the right to keep and bear arms, the right to trial by jury, the right to habeas corpus, the right to privacy, etc.; and

WHEREAS the security of our rights depends on the continuation of the independence of our constitutional Republic; and

WHEREAS members of the American foreign policy establishment and their counterparts in Europe established the European Coal and Steel Community (ECSC) in 1951, then worked closely together over the succeeding decades to transform the ECSC into the present-day regional government (consisting of 27 formerly independent nations) known as the European Union (EU) via a series of “free trade” agreements; and

WHEREAS Henry Kissinger, the dean of the American foreign policy establishment, wrote in 1993 that the USMCA’s predecessor, the North American Free Trade Agreement (NAFTA), “is not a conventional trade agreement but the hopeful architecture of a new international system,” and that NAFTA would “represent the most creative step toward a new world order taken by any group of countries since the end of the Cold War”; and

WHEREAS Robert Pastor wrote in the January/February 2004 issue of *Foreign Affairs*: “NAFTA was merely the first draft of an economic constitution for North America.... Although NAFTA fueled the train of continental integration, it did not provide conductors to guide it;” and

WHEREAS Canadian Deputy Prime Minister Chrystia Freeland, on December 10, 2019, at the signing ceremony for the “Protocol of Amendment to the Agreement Between the United States of America, the United Mexican States, and Canada,” in Mexico City, praised the “progressive” nature of the agreement and touted how “when this agreement is enacted, NAFTA will not only be preserved, updated, and modernized for the 21st century”; and

WHEREAS Mexican President Enrique Peña Nieto, at the signing ceremony for the USMCA in Buenos Aires, Argentina, on November 30, 2018, said, “The renegotiation of the new trade agreement sought to safeguard the vision of an integrated North America” and that “the Mexico-United States-and-Canada Treaty gives a renewed face toward our integration”; and

WHEREAS Mexican President Andrés Manuel Lopez Obrador (AMLO), on January 10, 2023, spoke to reporters about “the importance of ... seeking the union of the entire American continent”; and

WHEREAS President AMLO, on April 21, 2024, said in his remarks during an event marking the 110th anniversary of the U.S. occupation of Veracruz, “The important thing is how to strengthen this integration and compromise that is convenient for both nations, convenient for the United States and convenient for Mexico to strengthen North America and subsequently strengthen the entire American continent, just as the European community was created at the beginning and later became the European Union”; and

WHEREAS members of the American foreign policy establishment have worked with their counterparts in Mexico and Canada to create an NAU regional government (modeled after the EU) via NAFTA and the USMCA; and

WHEREAS the ultimate goal of the American foreign policy establishment and their fellow globalists around the world is to create a whole series of regional governments, such as the EU and the NAU, as steppingstones toward a UN world government; and

WHEREAS our nation’s participation in an NAU regional government and a UN world government would destroy American independence and the security of our rights; and

WHEREAS congressional approval of such “free trade” agreements as the USMCA amounts to an unconstitutional ceding of Congress’s exclusive power to “regulate commerce with foreign nations” to supranational layers of government, such as the trilateral Free Trade Commission provided for in Chapter 30 of the USMCA; and

WHEREAS the gradual creation of an NAU from a merger of the United States, Mexico, and Canada directly threatens our constitutionally protected freedoms and our nation’s independence, and implies an eventual end to national borders within North America; and

NOW, THEREFORE, BE IT RESOLVED by the Legislature of the State of _____, that the Congress of the United States, and particularly, the legislative delegation to Congress of the State of _____, are hereby urged and petitioned to use all their efforts, energies and diligence to withdraw the United States from the USMCA and prevent the creation of an EU-style North American Union.
